I am hoping you can assist with a question regarding eligibility for AusIndustry's incubator support program.

The ACT's <u>Renewable Energy Innovation Hub</u> is a flexible, collaborative co-working and office space in the heart of Canberra's wider renewable energy precinct and brings together innovative startups and pioneering organisations from Australia and around the world.

The incubator support program—in particular its expert in residence component—looks like a great opportunity to build on the hub's early success but we would be keen to determine whether the hub would be eligible for support under the scheme.

The hub is not at this stage a separate legal entity to the ACT government (although it is funded solely by industry contributions). Noting the scheme is open to local but not state governments, I guess the question hinges on whether the ACT as a territory with both state and municipal functions can apply. I understand the ACT has in the past been recognised as a local government for similar purposes.
