

As per our discussion, today NOPSEMA will issue a Direction and a Prohibition Notice to Timor Sea Oil and Gas Australia Pty Ltd, to ensure adequate oil spill response capability is maintained for the Northern Endeavour facility operations for production licence area AC/L5.

AC/L5 is in Commonwealth waters within NOPSEMA's regulatory jurisdiction. AC/L5 is immediately adjacent to, but not within, the Joint Petroleum Development Area which is administered by the National Petroleum Authority of Timor-Leste on behalf of the Governments of Australia and Timor-Leste.

This action is being undertaken following a request by NOPSEMA to Timor Sea Oil and Gas Australia Pty Ltd on 19 May for revision to be made to the Environment Plan covering AC/L5, due to changes in the manner in which the environmental impacts and risks of the activity were proposed to be managed.

It is important to note that no adverse environmental incident has occurred, NOPSEMA is undertaking the enforcement action is to ensure spill response capability is maintained.

NOPSEMA is required to publish the Prohibition Notice on it's website within 21 days of issuance, however we do not promote the publishing of notices. We do not expect media coverage of this action outside of industry press.
