In the PDF for Policy 9 – there is a section called **requirement 4** which sets out the expectations and obligations for Government agencies providing personnel temporary access to classified resources.

Paragraph 24 has the main details that Security Division truly care about, but if the personal already has provisional access granted – then **presumably the majority of these steps have been taken**. In particular: *“confirmation from the authorised vetting agency that the person has no identified security concerns, or a clearance that has been cancelled or denied”*.

In terms of safeguarding our (possible) SECRET information – it's well worth the agency in question just detailing in a document for accountability purposes that includes the below. It's good practice and if any issues arise then there is a document to point to that shows the decision making process.

- The level of information being accessed;
- How it will be accessed (verbal, hard copy, ICT system);
- Any risks as a result of this sharing of information; and
- Any mitigations – e.g. only in a Zone 4 or above, or a brief on the importance of need to know, or escorted access when looking at hard-copy documents, etc.

For completeness, the NPSTF division has asked for the above to be documented however if you can just answer the 2nd and last questions, I'm happy with the others.

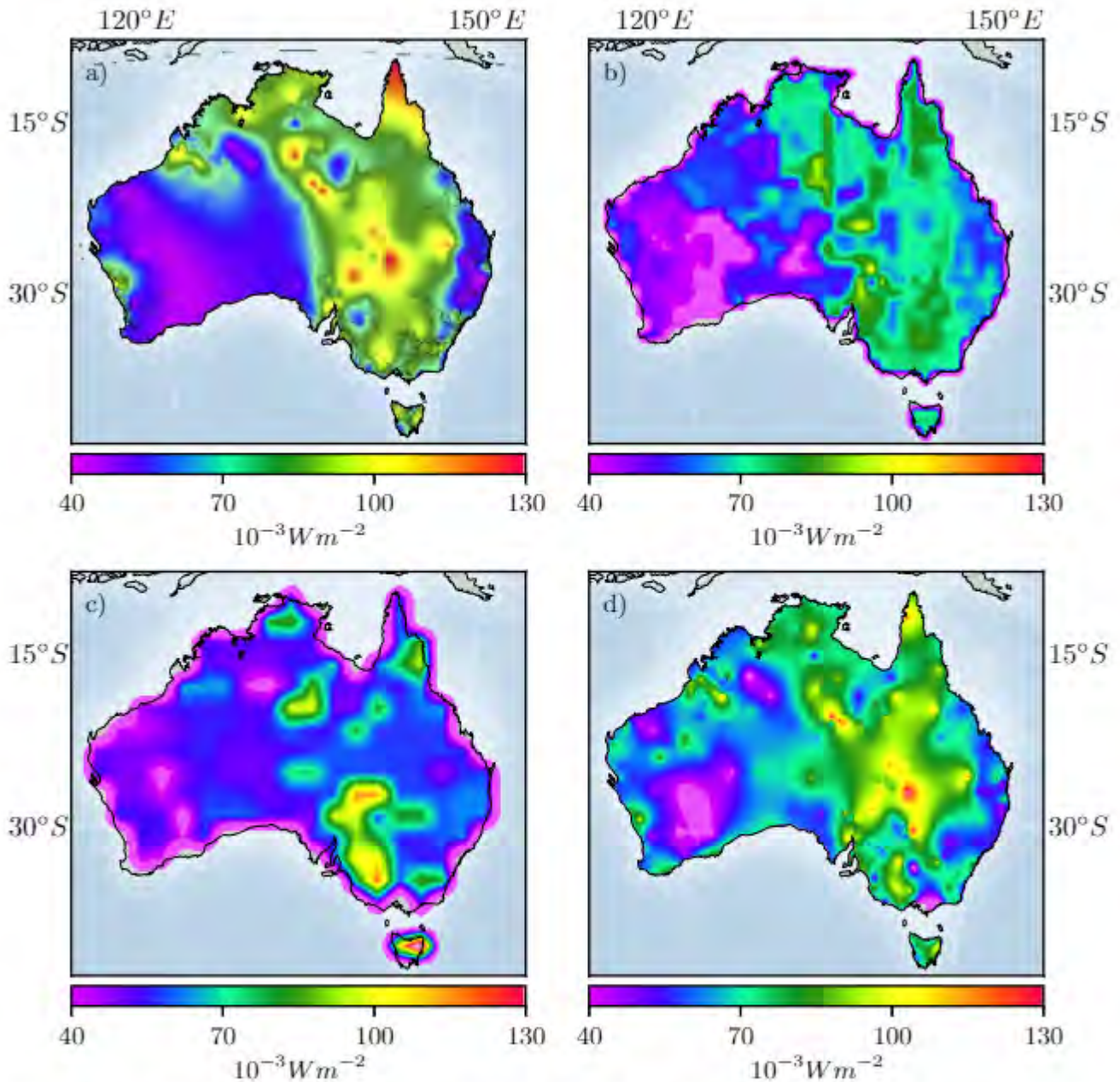


Figure 6.1: Australian surface heat flow grids. a) An unpublished grid produced by Hot Dry Rocks Pty Ltd in 2009 (Dr. Graeme Beardsmore, *personal communication*), as a merger of heat flow, bottom-hole temperature and thermal conductivity data. b) Extract from the 1° global interpolation from Goutorbe et al. (2011). c) Extract from the 2° global interpolation from Davie (2013). d) A tension in spline interpolation by Hasterok & Gard (2016).

MARLES: We are making a commitment that we will dispose of the nuclear reactor. That is a significant commitment to make. This is going to require a facility to be built in order to do that disposal. Obviously, that facility will be remote from populations and today we are announcing that that facility will be on Defence land, current or future. Now, to be clear, the first of the naval reactors that we will be disposing of will not happen until the 2050s. But within the year, we will announce a process by which this facility will be identified.

...

REPORTER: Is a high-level nuclear waste dump the price that South Australia will have to pay for the jobs that go to the state?

MARLES: Well, as I indicated there will be a process that we will determine within the next 12 months for how the site will be identified. You've made a leap there, which we're not going to make for some time. It will be a while before a site is ultimately identified. But we will within the next 12 months establish a process for how we walk down that path.

...

REPORTER: Just back on the waste issue, we've been squabbling for 30 years over where to bury low-level waste and it's still yet to be resolved. You've got less time than that to establish a high-level facility plus reprocessing. You've said Defence land. Would it not be easy to just make a decision to plonk it in Woomera, which is Defence land and already has waste up there?

MARLES: In respect of the first question, first thing, we are talking about more than 30 years from now is when the first of the reactors would need to be disposed of. So that is the timeframe. We will, in the course of the next year, announce a process by which that site will be identified. We're not about to identify right now. And there is plenty of time in which to identify. The point we are making though, and this is different from what's happened with the low-level nuclear waste site, is we are committing to the fact that it will happen on Defence land, be it current Defence land or future Defence land.

REPORTER: But you said future Defence land, you could acquire Kimba as the Defence location?

MARLES: Can I just answer the question, the answer to your question is Defence land. It's Defence land, is the answer.

So to respond to this document in writing, prior to the meeting. At the granularity of the rock types, I can see no significant issues on this subdivision, but some contextual note eluded to at various times previously.

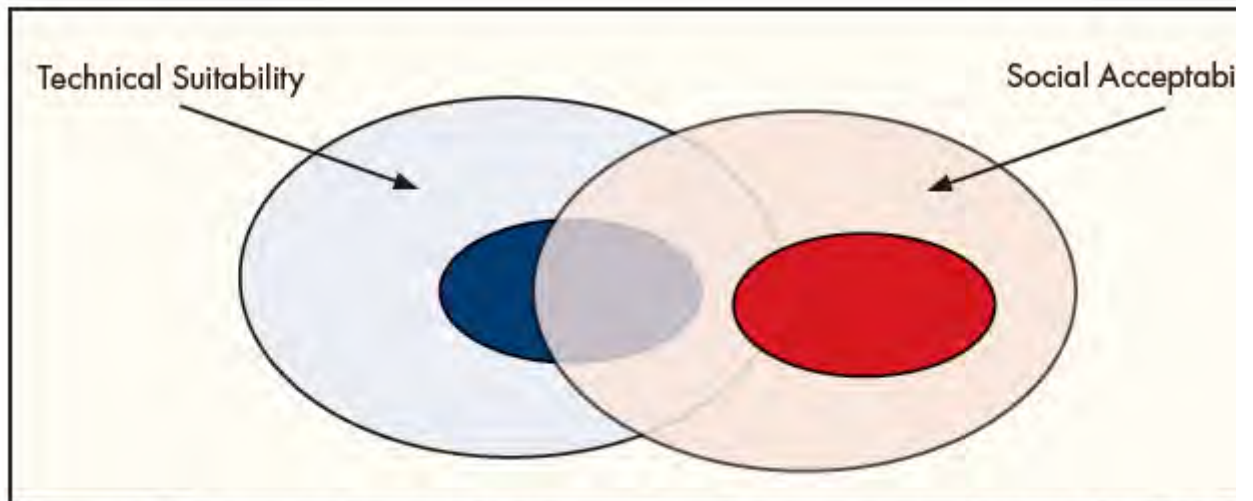


Figure 1. Selecting a site is an iterative process. It involves successive evaluations of technical suitability and social acceptability. Lighter shades denote early-stage judgments, and darker shades denote late-stage judgments.

- It is generally best practise to not use a binary approach to criteria or to rank any input as zero without a very good reason to do so. The rationale behind this is summarised in the following figure from US DoE and the following quote *“Waste-management programs need to find sites that belong to both the blue and red sets. At the early stage, many locations, prospective settings, remain in contention either because available information is insufficient to eliminate them or because, at that point in the process, the requirements for suitability and acceptability are looser. At the late stage, fewer locations remain in contention either because available information eliminates many others or because the requirements for suitability and acceptability have become more stringent. Ultimately, a handful of locations, candidate sites (not shown in Figure 1), emerge from the winnowing process. This figure has been intentionally drawn to show no overlap at the late stage because, as is often the case, no site is both technically suitable and socially acceptable. Faced with this outcome, the implementer has to choose between at least two fundamentally different courses of action. It can suspend the site-selection process to obtain additional information, or work on the social aspects in the hope that improved or evolving knowledge about suitability and/or changes in attitudes toward acceptability would permit the selection of a site. If that hope is not realized, however, the implementer may be forced to launch an entirely new site-selection process. In Canada, France, Germany, Japan, Sweden, Switzerland, the United Kingdom, and the United States, the implementer did precisely that. Alternatively, the implementer could explicitly or implicitly decide to alter the technical suitability and social acceptability requirements (or both) so that locations that had been (or might have been) rejected are now deemed satisfactory. locations, potential sites, remain in contention.”* An example of this may be sediments that have reported carbonate content, yet no reported karst or sinkholes. These may be ranked low, but *not zero or very low*. The extreme end member of this is that large areas of limestone with known collapse structures could conceivably be ranked lowest or perhaps excluded. s47C

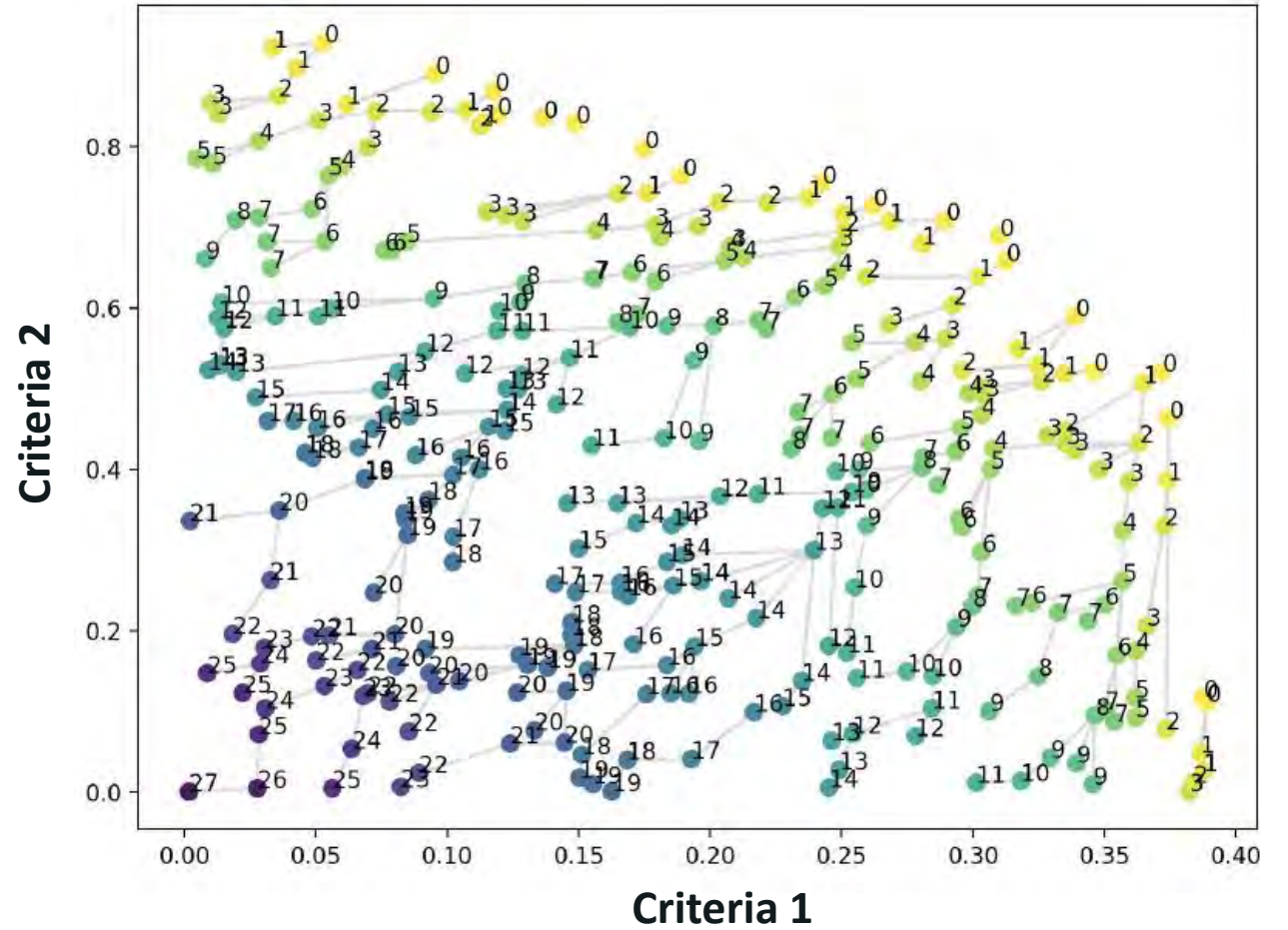
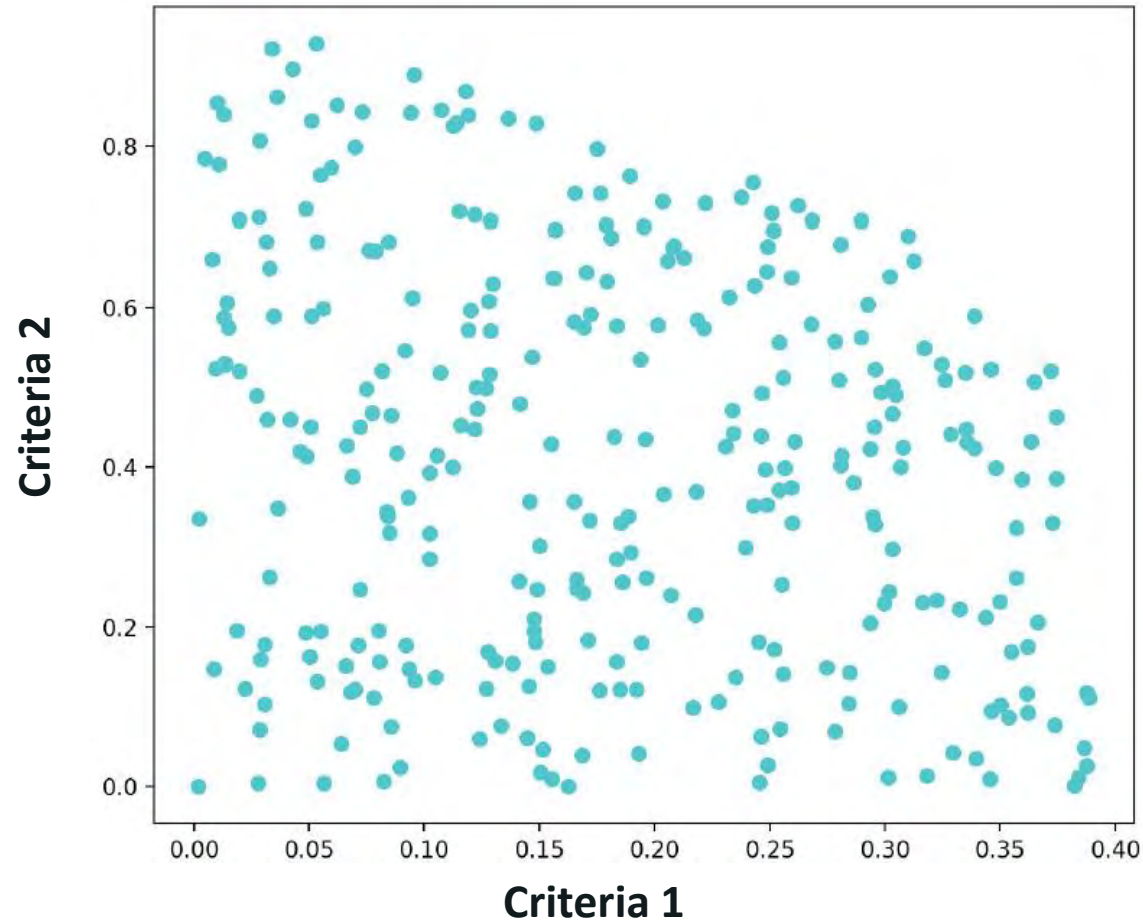
How to combine distinct sources of information? – Pareto-ranking

- As we combine geological, economic, environmental, social and governance considerations their distinct metrics are difficult to reconcile
- Our stakeholders have different goals and views of what is a priority
- However, this does **not** mean that there is no such thing as a “bad project”, some projects/locations will **always** be selected ahead of others
 - E.g. No reasonable stakeholder would select projects that have worse environmental impacts, create fewer jobs and generate less value
- The challenge is how to effectively evaluate and communicate these competing criteria, and identify potential projects/locations that perform best under a range of competing metrics?
- These options are “Pareto efficient” and make up the border of the Pareto frontier
- The Pareto ranking indicates the “distance” from the frontier
 - i.e. Rank 0 projects are on the frontier
 - Rank 1 projects would be on the frontier if Rank 0 were removed
 - And so on...

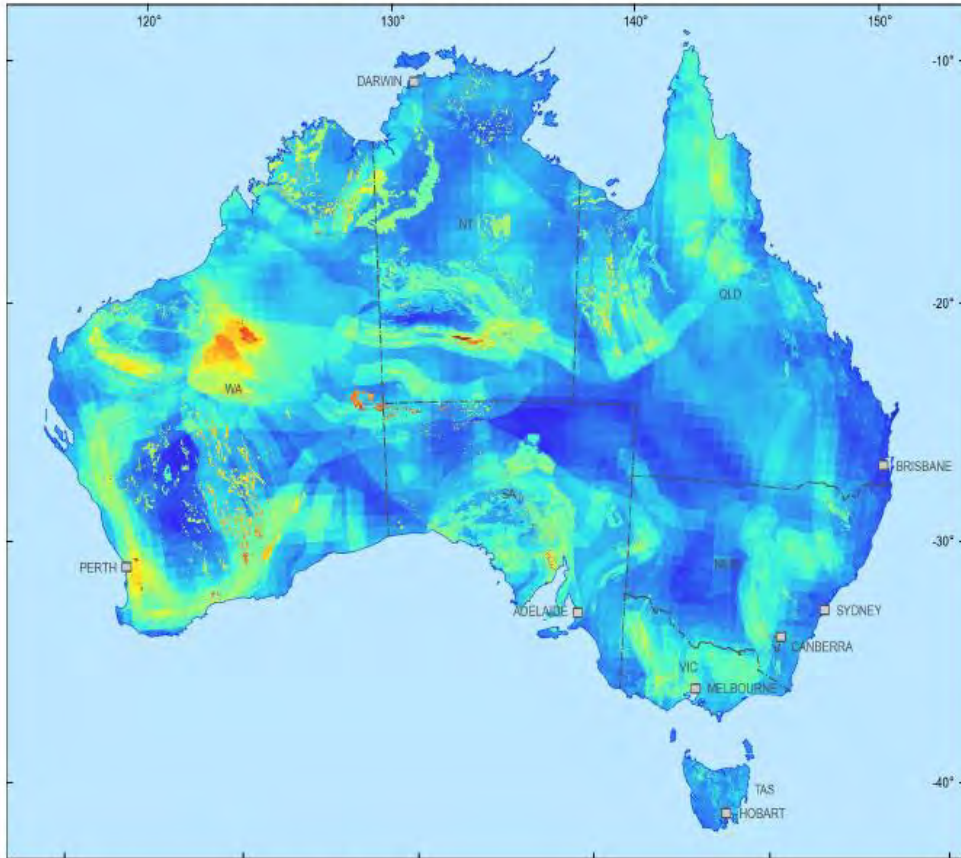
Simple Pareto Ranking Example



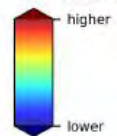

The Nuclear Communications Group – Terms of Reference

Context

The Australian Government is broadening its investment in nuclear technologies to better serve Australia's national interests, with touchpoints across multiple policy, technology and regulatory agencies.

Most significantly, this includes the nuclear-powered submarine program to support Defence and ANSTO's upgrades to nuclear security science, nuclear research capabilities and through securing our sovereign supply of potentially life-saving nuclear medicines.

The Australian Government will also provide long term support for ARWA to establish Australia's National Radioactive Waste Management Facility to safely and responsibly manage the radioactive waste by-products. Also support to strengthen and broaden Australia's nuclear regulatory environment through ARPANSA and ASNO and the development of a new Defence regulator for nuclear-powered submarines.

Effective and strategic communications is critical to the ongoing success of Australia's nuclear agencies.

Managing public perception of nuclear science and technologies (NST) remains challenging. Nuclear technologies are complex and due to historical incidents, there can be fear surrounding the safety and security of nuclear materials and the longer-term risks of safely managing radioactive waste.

These issues of safety and radioactive waste management cut across all nuclear programs – civil and military – and are not exclusive to any single nuclear agency.

With this broader range of nuclear activity, there is an opportunity to work collaboratively across the nuclear agencies, employing a whole of Government approach, to ensure there is greater co-ordination of effort and consistency in public messaging across communications and stakeholder engagement activities to support and develop Australia's nuclear social licence.

Through effective strategic communications, particularly in the past 10 years, ANSTO has turned-around public perception of its operations, and developed the basis for Australia's nuclear social licence. In the December 2022 sentiment survey, the vast majority of the community surveyed have either favourable or neutral feelings and impressions, with only 3% having unfavourable views. ANSTO has worked collaboratively with the Department and more recently ARWA to leverage ANSTO's social licence to support progress with the establishment of the National Radioactive Waste Management Facility (NRWMF). Progress made towards the establishment of a NRWMF and this has mutually benefited both ANSTO and ARWA.

More broadly however, polling by Essential in 2019 found that a majority of the sample (63%) thought a nuclear industry in Australia would create skilled jobs, and while some 44% of Australians support nuclear power plants, 60% said they would not be comfortable living close to nuclear energy facilities. There is a clear disconnect between the benefits that can be delivered by the nuclear

industry and the level of public awareness and acceptance around the industry and its known challenges.

The newly-announced submarine program is expected to create 20,000 jobs, many of which will require specialist nuclear expertise that Australia currently does not have. This is in addition to the 1,200 already employed at ANSTO, and growing numbers across ARWA, ASNO and ARPANSA.

There is a significant workforce requirement that does not currently exist on the scale the country needs to support the planned industry growth, and establishing stable social licence, a good reputation and a sense of excitement and momentum is key to developing and retaining that workforce.

Australia's nuclear agencies working collaboratively across our public engagement activities particularly, will result in a co-ordinated and consistent voice on nuclear related matters, and lead to an increase in our shared social licence that is fundamental to the progress of nuclear programs and the development of the nuclear workforce of the future.

The Nuclear Communications Group Terms of Reference

The Nuclear Communications Group is an informal inter-departmental committee of the Australian Government which meets fortnightly . The Nuclear Communications Group is not a decision or policy-making body, and meetings are held at the Official: Sensitive level. One meeting per quarter is to be held in person and the location of this meeting will rotate across the nuclear agencies.

The purpose of the Nuclear Communications Group is to:

- Ensure a clear and consistent narrative for internal and external communication activities produced by members and targeted at domestic and international audiences Achieve greater co-ordination of effort through sharing information on activities being undertaken which are of relevance or interest to the other participants to provide visibility on planned activities and emerging communications risks.
- Ensure credibility of messages being shared with the public across all nuclear agencies, to help ensure that decisions made, policy developed, and advice given by its participants is fact-based, informed, and cognisant of other participating agencies' public information, actions, and mandates.
- Set a common approach or posture for how we engage with the wider Australian public and the region on nuclear matters.
- Seek peer level advice on operational communications matters and suggest matters to be taken up by participants agencies outside the meeting.
- Assist in the management of resources across government by combining activities, resources and expertise where possible, identify efficiencies in sharing resources including photography/video, misinformation and disinformation analysis and other communications resources.

Governance

Meet fortnightly via Govt. Teams or similar platform

The meeting will be chaired by ANSTO, with a view that this position rotates around the agencies annually.

Attendance and agreed actions from each meeting are documented and shared amongst participants.

The Nuclear Communications Group will seek to provide updates to the Heads of Agencies meeting and the Nuclear Agencies Consultative Committee as opportunities arise.

Membership

Membership of the Nuclear Agencies Communications Meeting will comprise of nominated communications experts from:

The Australian Nuclear Science and Technology Organisation (ANSTO)

The Australian Radioactive Waste Agency (ARWA)

The Australian Safeguards and Non-Proliferation Office (ASNO)

Australian Submarine Agency (ASA)

The Australian Radiation Protection and Nuclear Safety Agency (ARPANSA)

Soon to be established nuclear regulator for Defence.

Other participants include communications experts from the member agencies and other guests as invited by the group.

Deliverables

The development, implementation, and evaluation of a shared national communications strategy to support public engagement and the development and maintenance of Australia's nuclear social licence. A shared strategy to be developed by Dec 2023.

Background

History

The Nuclear Agencies Communications Committee commenced in January 2023 to support public engagement towards the announcement of the AUKUS pathway for nuclear powered submarines (NPS).

The group met regularly and worked collaboratively to ensure that all nuclear agencies were co-ordinated in our public engagement activities in the lead up to and surrounding the NPS announcements.

In March 2023 it was agreed to define terms of reference of the committee and set a way forward for ongoing regular engagement and to broaden the scope of support across all nuclear programs from Government.

To avoid confusion with already established Nuclear Agencies Consultative Committee (NACC) a name change was proposed.

Excerpts from IAEA SSG-35 Site Survey and Site Selection for Nuclear Installations**Summary Comments (from ANSTO)**

s47E(d)

From SSG 35:

The fundamental safety objective is to protect people and the environment from harmful effects of ionising radiation. Adequate site selection and the incorporation of good design and engineering features providing safety margins, diversity and redundancy is required.

Need to evaluate a site with regard to:

- “(a) The effects of external events occurring in the region of the particular site (these events could be of natural origin or human induced);
- “(b) The characteristics of the site and its environment that could influence the transfer to persons and the environment of radioactive material that has been released; 2
- “(c) The population density and population distribution and other characteristics of the external zone in so far as they may affect the possibility of implementing emergency

measures and the need to evaluate the risks to individuals and the population.” (Ref: NS-R-3 para.2.1; NOTE NS-R-3 does not cover the initial stage of site survey when studies and investigations are performed at the regional level to identify potential sites.)

Siting is intended to:

- prevent accidents arising from external hazards associated with external events (comprehensive process to screen out sites for which external hazards are significant or could become significant)
- Screen out sites for which for which additional safety measures in design would be excessively demanding
- Reduce possible impacts on people and the environment (selection of a site with favourable dispersion characteristics for radionuclides in the air, surface water, subsurface water)
- Have a terrain, population distribution and infrastructure that facilitates implementation of an emergency plan

Siting process needs clearly established set of criteria which are balanced between characteristics of a site and specific design features, site protection measures and administrative procedures.

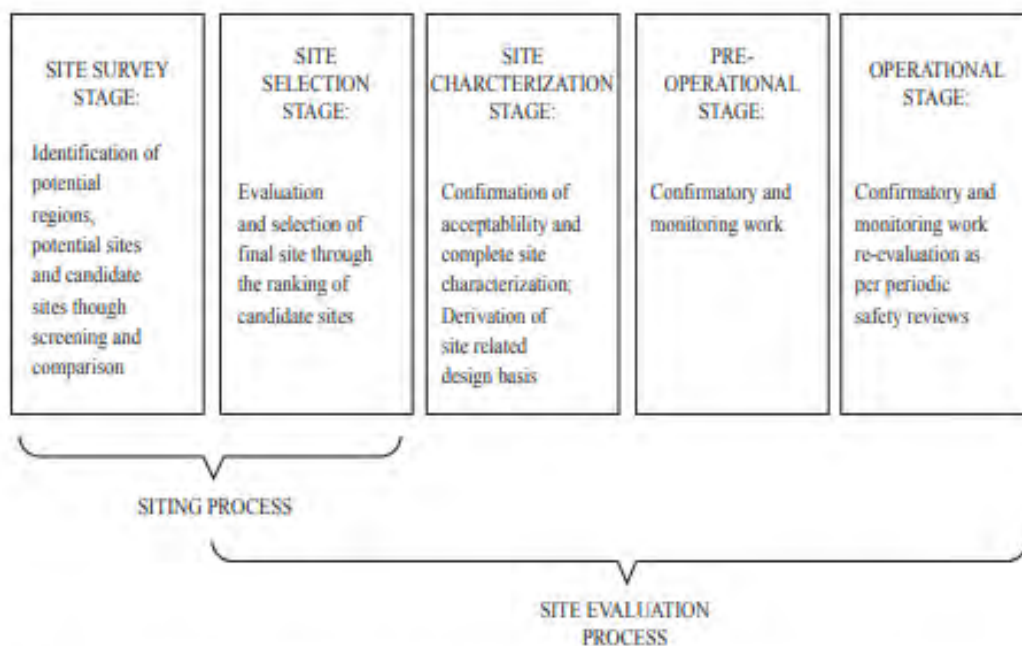


FIG. 1. Stages in the siting process and site evaluation process in the operating lifetime of a nuclear installation.

In the site survey stage, large regions are investigated to find potential sites and to identify one or more candidate sites. The second stage of the siting process is site selection in which unsuitable sites

are rejected and remaining candidate sites are assessed by screening and comparing them on the basis of safety and other considerations to arrive at preferred candidate sites.

Chapter 3 – General recommendations for the siting process

3.1. The siting process is intended to select suitable locations for the envisaged nuclear installation such that its characteristics are compatible with available engineering protective measures for all natural and human induced hazards arising from external events, so that the necessary level of safety can be achieved. Furthermore, the surrounding demographic setting and dispersion characteristics should be such as to limit the exposure of the population for any plant state to as low as reasonably achievable, and to allow the implementation of measures for mitigating the consequences of any accidental release of radionuclides over the operating lifetime of the installation.

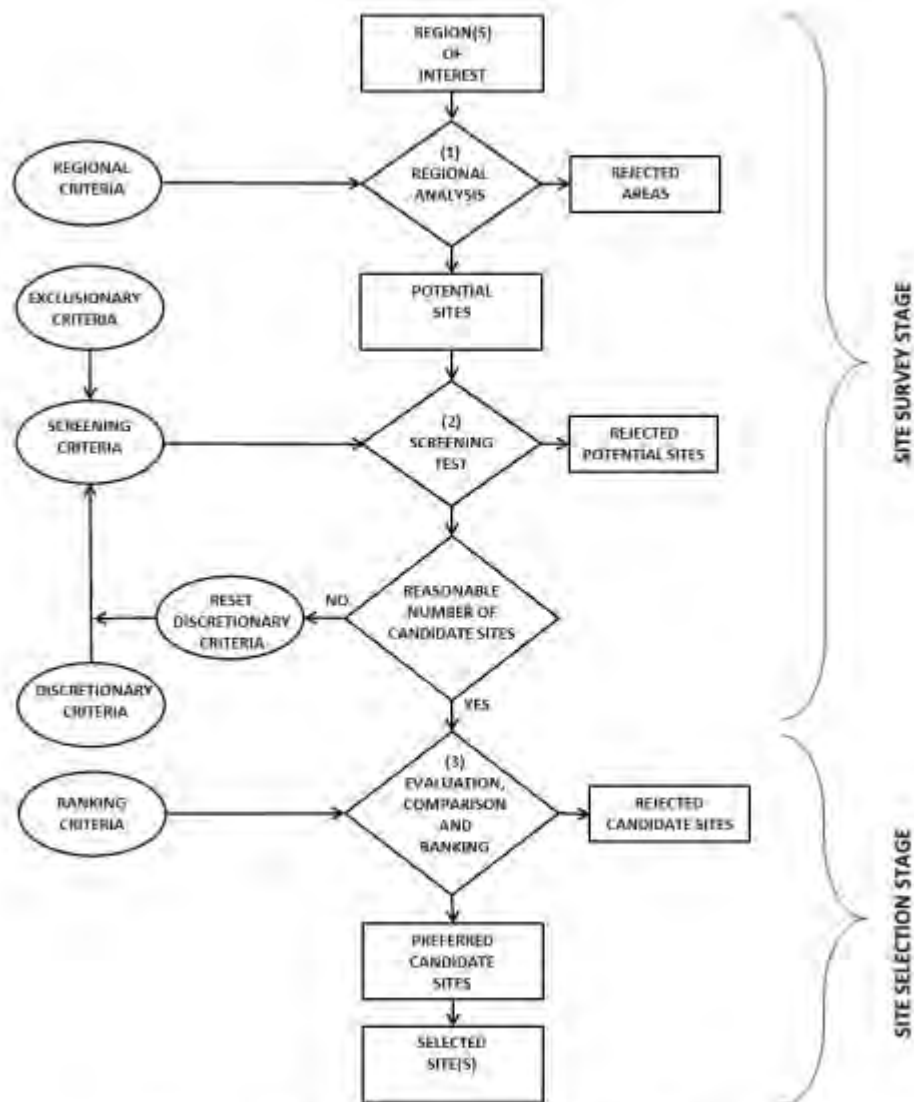


FIG. 3 Flow chart for the siting process for a nuclear installation.

3.2. The siting process consists of a series of related activities with the objective of selecting suitable sites for a new nuclear installation. The process should systematically and successively apply a number of screening criteria to screen out those sites with attributes which contribute unfavourably to the safety of the installation. A flow chart of the siting process for a nuclear installation is given in Fig. 3.

3.3. The siting process has three distinct steps starting with the region(s) of interest as given.

(1) Regional analysis: This is the first step, in which region(s) of interest are analysed to identify potential sites. All potential sites in a region should be taken to the next step (screening) unless their exclusion can be appropriately justified.

(2) Screening: In the second step, the potential sites are screened to choose the candidate sites. The principal objective of this step is to exclude unfavourable sites on the basis of both safety related considerations and non-safety-related considerations

SITING CRITERIA

3.6. Siting criteria provide the basis on which decisions are made in consideration of the site attributes in the different steps of the siting process. Siting criteria are used to evaluate specific site related issues, events, phenomena, hazards and other considerations after the site has been investigated and analysed. As is shown in Fig. 3, there should be three categories of siting criteria: regional criteria, screening criteria and ranking criteria.

3.7. The regional analysis should be carried out to identify potential sites using well established regional criteria. Regional criteria are generally related to national domestic policy, national economic policy, national and international environmental protection or other related policies of the State. Technical constraints and the availability of resources (e.g. infrastructural constraints, availability of water) on a regional basis should also be important considerations for regional

analysis. The regional criteria should identify all possible potential sites and no site should be discarded without appropriate justification.

3.8. The screening of potential sites should be conducted using screening criteria of two types:

— *Exclusion criteria*: The exclusion criteria are used to discard sites that are unacceptable on the basis of attributes relating to issues, events, phenomena or hazards for which there are no generally practicable engineering solutions.

— *Discretionary criteria*: The discretionary criteria are associated with those attributes relating to issues, events, phenomena, hazards, or other considerations, for which protective engineering solutions are available. These criteria, listed in Table I-1 of Annex I, are used to facilitate the selection process through iterative screening to eliminate less favourable sites when there are a large number of possible candidate sites

GENERAL BASIS FOR SCREENING CRITERIA

3.11. Exclusion criteria should be established and used as part of the screening at the site survey stage. Screening by exclusion criteria enables sites with unfavourable characteristics to be excluded from further consideration.

3.12. Exclusion criteria should be selected for the negative attribute of a site characteristic, or for any site related issue, event, phenomenon or hazard for which engineering, site protection or administrative measures are not available or are excessively demanding.

3.13. Exclusion criteria encompass not only inherent weaknesses in a site's characteristics, but also the feasibility of engineering solutions to compensate for such weaknesses, either through design or through site protection measures. Therefore, the existence of a certain hazard or even the high likelihood of its occurrence should not constitute the sole basis upon which an exclusion criterion is based. Screening out on the basis of an arbitrary criterion may lead to the discarding of a site with otherwise favourable qualities for safety and may finally result in the choice of a site that is less safe than the site that has been discarded.

3.14. Discretionary criteria should be established: — To decrease the number of possible candidate sites if their number is too large to conduct the exercise of comparison and ranking

Chapter 4 – Classification of siting Criteria p20

Criteria used in the siting process for a nuclear installation are classified as follows:

- Safety related criteria;
- Criteria relating to nuclear security;
- Non-safety-related criteria. Such criteria may be screening criteria (i.e. exclusionary or discretionary criteria) or ranking criteria

Safety related criteria:

- (a) Capable faults (i.e. faults that may cause surface displacement near the nuclear installation);
- (b) Vibratory ground motion due to earthquakes;
- (c) Volcanic hazards;
- (d) Coastal flooding or low water intake level (including inundation as well as receding water levels due to wave action, storm surges, seiches or tsunamis);
- (e) River flooding (overtopping of banks due to failure of water retaining structures such as dykes or dams) or low water intake level due to low river flow or drought;
- (f) Blockage of intake channels (e.g. due to marine organisms, ice, debris, ship collisions, oil spills or fires);
- (g) Combinations of coastal and river flooding (e.g. in estuaries), and flash floods due to intense precipitation or downbursts;
- (h) High winds — both straight winds such as hurricanes and tropical storms and rotational winds such as tornadoes;
- (i) Local phenomena such as sand storms and dust storms;
- (j) Other extreme meteorological events such as droughts, extreme precipitation, including snow pack, extreme hail, lightning and extreme temperatures, including the temperature of the source of cooling water;
- (k) Geotechnical hazards such as slope instability, soil liquefaction, landslides, rock fall, avalanche, permafrost, erosion processes, subsidence, uplift and collapse;
- (l) Forest fires;
- (m) Credible combinations of events (i.e. combinations of both dependent and independent events that potentially could lead to more severe consequences than for a single hazard, such as a seismic event together with flooding, or wind together with snow).

4.4. The second set of criteria is related to the potential impacts of human induced events and nuclear security events on the safety of the nuclear installation. In this context and in accordance with the recommendations of NS-G-3.1 [4], the following origins of potential human induced hazards should be considered:

- (a) Stationary sources:
 - (i) Other nuclear installations, oil and gas operations, chemical plants, processing of hazardous materials such as commercial facilities for manufacturing or storing munitions, broadcasting and communication networks, mining or quarrying operations, high energy rotating equipment and hydraulic engineering structures;
 - (ii) Military facilities (permanent or temporary), especially shooting ranges and arsenals.
- (b) Mobile sources:
 - (i) Surface transportation (e.g. railways and roads, and oil, gas and other pipelines);
 - (ii) Airport zones and harbour zones (military and civilian);
 - (iii) Air traffic corridors and flight path zones (military and civilian).
- (c) Electromagnetic interference.

4.5. The third set of criteria is related to the characteristics of the site and its environment that could influence the transfer of radioactive material released from the nuclear installation to people and the environment. In this context and in accordance with the recommendations of NS-G-3.2 [5], the following phenomena should be considered:

- a) Atmospheric dispersion of radioactive material;
- b) Dispersion of radioactive material in surface water;
- c) Dispersion of radioactive material in groundwater;
- d) Population density and population distribution and distance to centres of population, including projections for the operating lifetime of the nuclear installation.

4.6. The fourth set of criteria is linked to the third set but it relates mainly to the demonstration of the feasibility of implementation of the emergency plan for the nuclear installation. In this context, the following phenomena should be considered:

- a) Physical characteristics of the site that could hinder implementation of the emergency plan (in particular, geographical features such as islands, mountains and rivers);
- b) Infrastructural characteristics relating to the implementation of the emergency plan (especially local transport infrastructure and communications networks)
- c) Considerations of populations (e.g. special population groups with regard to protective actions in the event of a nuclear or radiological emergency, such as elderly and disabled persons and hospital patients and prisoners), and land and water use considerations;]
- d) Specific requirements of the regulatory body for special zones, such as emergency planning zones and distances;
- e) Industrial facilities that could involve potentially hazardous activities;
- f) Impacts of concurrent external hazards on infrastructure

Other considerations

- a) Nuclear security considerations
- b) Technology
- c) Economics
- d) Land use planning
- e) Non-radiological environmental impacts
- f) Socioeconomic impacts
- g) Opinion of interested parties including the public
