












Enabling Innovation Index Ranking: 49th of 104

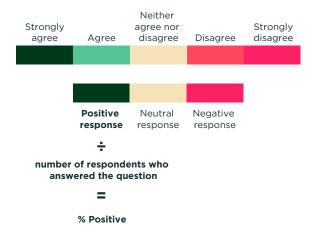
