On behalf of the Chinese company **Shanghai Taisheng Wind Power Equipment Co.**, **Ltd** ("**Shanghai Taisheng**"), we would like to ask for an extension of 30 days for the submission of responses to the Exporter's Questionnaire, which will be issued by the Anti-dumping Commission in the above-mentioned investigation, for the following reasons:

- This is the first time Shanghai Taisheng is subject to an antidumping investigation initiated by a foreign country, thus the company would need to digest all legal and factual elements in connection with such an investigation, especially the information and data requested in the questionnaire;
- The period of October 1 through October 7 will be a national public holiday in China, during this period all entities and companies will be closed and the company's employees will return back to their hometowns. Even after this holiday, the employees would need to spend time to get back to the company. The company would need to spend time to coordinate and mobilize the human resources for the preparation of the questionnaire responses;
- 3) As Shanghai Taisheng is a publicly listed company, the financial department is currently under significant workload to prepare the quarterly financial statements.

Therefore, based on the above situation, we respectfully request for an extension of 30 days for the submission of the questionnaire responses (it is noted the initial deadline for
