Customs Act 1901 - Part XVB

Ammonium nitrate Exported from the Russian Federation (either directly or via Estonia) Expiry of anti-dumping measures

Public notice under subsections 269ZHB(1) of the Customs Act 1901

I, Dale Seymour, Commissioner of the Anti-Dumping Commission, in accordance with subsection 269ZHB(1) of the *Customs Act 1901* (the Act), advise that the anti-dumping measures on ammonium nitrate ("the goods") exported to Australia from the Russian Federation (either directly or via Estonia) are due to expire on 24 May 2016.

The measures were initially imposed by public notice on 24 May 2001 by the then Minister for Justice and Customs following consideration of *Trade Measures Report No.*28 (REP 28).

Those persons as specified at subsection 269ZHB(1)(b) of the Act are invited to apply for the continuation of the anti-dumping measures. The application must be in writing, be in an approved form, contain such information that the form requires and be signed in the manner indicated in the form. Applications must be lodged within 60 days from the publication of this notice.

The application must provide evidence addressing whether there appear to be reasonable grounds for asserting that the expiration of the anti-dumping measures to which the application relates might lead, or might be likely to lead, to a continuation of, or a recurrence of, the material injury that the measures are intended to prevent.

If an application is received that complies with the prescribed requirements and I decide not to reject that application, the Anti-Dumping Commission (the Commission) will undertake an inquiry and I will report to the Parliamentary Secretary to the Minister for Industry and Science (the Parliamentary Secretary) within 155 days (or by such later date as the Parliamentary Secretary may allow in accordance with subsection 269ZHI(1)(g) of the Act).

If no application is received by the Commission within the period specified above, the anti-dumping measures applying to the goods exported from the Russian Federation, (either directly or via Estonia), will expire on 24 May 2016. Therefore on and from 25 May 2016 anti-dumping measures would no longer apply to the goods.

Expiry of anti-dumping measures

I, Dale Seymour, Commissioner of the Anti-Dumping Commission, in accordance with subsection 269ZHB(1) of the *Customs Act 1901* (the Act), advise that the anti-dumping measures on ammonium nitrate exported to Australia from the Russian Federation (either directly or via Estonia) are due to expire on 24 May 2016.

The anti-dumping measures were initially imposed by public notice on 24 May 2001 by the then Minister for Justice and Customs following consideration of *Trade Measures Report No.28.*

Those persons specified at subsection 269ZHB(1)(b) of the Act are invited to apply for the continuation of the anti-dumping measures. The application must be in writing, be in an approved form, contain such information that the form requires and be signed in the manner indicated in the form.

A notice advising the expiry of these anti-dumping measures was published in *The Australian* newspaper on 13 July 2015. Applications must be lodged by 11 September 2015.

The application must provide evidence addressing whether there appear to be reasonable grounds for asserting that the expiration of the anti-dumping measures to which the application relates might lead, or might be likely to lead, to a continuation of, or a recurrence of, the material injury that the measures are intended to prevent.


If an application is received that complies with the prescribed requirements and I decide not to reject that application, the Anti-Dumping Commission (Commission) will undertake an inquiry and I will report to the Parliamentary Secretary to the Minister for Industry and Science (the Parliamentary Secretary) within 155 days (or by such later date as the Parliamentary Secretary may allow in accordance with subsection 269ZHI(1)(g) of the Act). The Commission will publish a notice advising the commencement of such an inquiry. If no application is received by the Commission within the period specified above, the antidumping measures applying to ammonium nitrate exported from the Russian Federation (either directly or via Estonia) will expire on 24 May 2016. Therefore on and from 25 May 2016 anti-dumping measures would no longer apply.

Orica cuts production at Gladstone

Orica has announced a reduction in production and jobs at its Gladstone Yarwun site.

Around 40 positions will be cut from the operation, although of these 11 are understood to already be vacant, **according to the Gladstone Observer.**

It comes on the back of earlier statements by the explosives manufacturer that it **sought to cut around 700 positions globally from its operations.**

These reduction form part of the company's

program of 'efficiency improvements' which delivered savings of around \$69 million in 2014, with the ongoing program encouraging the company to reset its cost base for 2015.

As part of the reduction of workforce, Orica is also shrinking output from 320,000 tonnes of ammonium nitrate to 280,000 to this year.

The jobs are expected to go by the end of this week.

"Today, we have begun consulting with our employees to understand and address any impacts on the workforce," Yarwun general manager **Dave Buick explained in a company statement.**

"We expect there will be some impact on staffing levels from this decision."

He went on to say there will be a complete business review carried out, outlining the reasons behind the workforce reduction.

"We make a couple of products, and will be doing a business review of the entire structure," he said.

"While we remain confident in the long term outlook for ammonium nitrate, there is a near term oversupply in the market.

"The forecast for next year is such that we will take half the plant offline. But we will have it sitting there so if needed it can be turned back on.
