# Ministerial Exemption Instrument No. 5 of 2014 Customs Tariff (Anti-Dumping) Act 1975

I, ROBERT CHARLES BALDWIN, Parliamentary Secretary to the Minister for Industry, have considered and accepted the recommendations of the Commissioner of the Anti-Dumping Commission, the reasons for the recommendations, the material findings of fact on which the recommendations are based and the evidence relied on to support those findings in Anti-Dumping Commission Report EX0021 Zinc Coated (Galvanised) Steel exported to Australia from the People's Republic of China (China), the Republic of Korea (Korea) and Taiwan.

Under subsection 8(7) and 10(8) of the Customs Tariff (Anti-Dumping) Act 1975, I hereby exempt the goods described in Attachment 1 (the Goods) from:

- interim dumping duty and dumping duty, and
- interim countervailing duty or countervailing duty,

as I am satisfied that a Tariff Concession Order under Part XVA of the Customs Act 1901 in respect of the Goods is in force.

The anti-dumping measures previously applying to the Goods were imposed following the then Attorney General's consideration of the then International Trade Remedies Branch's Final Report Nos. 190 and 193 concerning alleged dumping and subsidisation of zinc coated (galvanised) steel and aluminium zinc coated steel exported from China, Korea and Taiwan.

## CURRENT Tariff Concession Order (TCO) for tariff classification 7210.49.00

All goods meeting the description detailed below for the current TCO are eligible for an exemption from dumping duties and countervailing duties under Ministerial Exemption Instrument No. 5 of 2014.

#### TC 1342242

STEEL, flat rolled, non-alloy, hot dipped zinc coated, in coils, having ALL of the following:

- (a) yield strength NOT less than 340 MPa and NOT greater than 420 MPa;
- (b) tensile strength NOT less than 410 MPa;
- (c) elongation NOT less than 21%;
- (d) coating mass NOT less than 60 g/m2 and NOT greater than 90 g/m2 on each side; and
- (e) thickness 2.00 mm and width 1 045 mm.

For the purposes of this Order, tolerances allowable for specification (e) are:

- (a) thickness +/- 10%; and
- (b) width +/- 1%.

### TC 1342243

STEEL, flat rolled, non-alloy, hot dipped zinc coated, in coils, having ALL of the following:

- (a) yield strength NOT less than 180 MPa and NOT greater than 240 MPa;
- (b) tensile strength NOT less than 300 MPa;
- (c) elongation NOT less than 33%;
- (d) coating mass NOT less than 60 g/m2 and NOT greater than 90 g/m2 on each side; and
- (e) thickness 1.20 mm and width 1,020 mm.

For the purposes of this Order, tolerances allowable for specification (e) are:

- (a) thickness +/- 10%; and
- (b) width +/- 1%.
