Investigation of alleged dumping and subsidisation of silicon metal exported from the People's Republic of China

I refer to the Anti-Dumping Commission's (the Commission) investigation into the alleged dumping and subsidisation of silicon metal and the Government of China's (GOC) submission dated 18 April 2014.

I understand that the GOC has raised concern with respect to the provision of information to the Commission in respect to the current investigation, as it is of the view that the information has been previously provided. Whilst I appreciate the concern, in order for the Commission to make an accurate assessment of the markets relevant to this investigation, further information is required.

Could you please provide the following documents and information to the Commission by 16 May 2014:

1. Chinese electricity tariff rates for 2013 by province
2. For the period January 2009 to December 2013 as applicable to silicon metal:
 - a) VAT rebates
 - b) Export tariff rates
 - c) Import tariff rates
 - d) Export quotas
 - e) Corporate income tax rates
3. The Silicon Industry Branch of the China Nonferrous Metals Industry Association Rules
4. Document of the Office of People's Government of Yunnan Province (Yun Zheng Ban Fa [2012] No. 236) – Options Concerning Promoting Industrial Restructuring of Industrial Silicon
5. China Nonferrous Metals Yearbooks for the years 2011, 2012 and 2013

6. Ministry of Industry and Information Technology's (MIIT) published lists of specific ferroalloy enterprises required to eliminate backward production capacity for the years 2010 to 2013
7. Yunnan Government publication "Market Access Conditions for the Ferroalloy Industry"
8. 12th Five-Year plans including:
 - 12th Five-Year Development Plan for the Non-Ferrous Metals Industry, which includes the sub-plan, The 12th Five-Year Development Plan for the Aluminium Industry;
 - 12th Five-Year Development Plan for the New Materials Industry;
