Dear John and Pamela,

We refer to our email below and as you are aware we act for Hyosung in relation to its involvement in the investigation regarding allegedly dumped Electrical Power Transformers.

Hyosung has instructed us to request an extension of time to 4 October 2013 to submit the following to the ADC:

1. the Exporter Questionnaire; and
2. a general submission in response to the Consideration Report.

Hyosung makes this request for a number of reasons.

First, as discussed during Hyosung's conference call with the ADC on 14 August 2013, Hyosung has a number of concerns regarding the scope of the product concerned, the methods used by the ADC to calculate the dumping margin and other preliminary issues that require clarification. We are currently advising Hyosung on these matters and, as you are aware, we are in the process of arranging a meeting between ourselves, representatives from Hyosung and the ADC on 3 September 2013 to discuss these matters.

Second, a significant number of Hyosung's employees have been on leave in August due to the summer holidays in Korea. As a result, Hyosung has not had sufficient personnel to prepare the comprehensive response required by the questionnaire. Further, many employees will also be absent during the week starting 16 September 2013 for the Korean Thanksgiving holidays.

Given the need to clarify certain issues and the reduced capacity to undertake the significant work required to complete the submissions, Hyosung would be grateful if the ADC could grant an extension of time to 4 October 2013.

We look forward to hearing from you shortly.
