We act on behalf of Stora Enso Timber Australia Pty Ltd ("SETA") and its related entities (collectively, "Stora Enso Group").

The Stora Enso Group

The Stora Enso Group is the largest timber producer in Europe.

SETA is a wholly owned subsidiary of Stora Enso Wood Products Oy Ltd and member of the Stora Enso Group. It operates from four distribution centres located in Melbourne, Brisbane, Adelaide and Gosford. Sales are also made in Perth through a wholesaler/s

SETA's main product range is timber framing material for wall and truss manufacturing and this is supplied mostly from the Stora Enso Group sawmills in the Baltics, Nordic and Central Europe.

Other products include weatherboards and a limited range of joinery products mostly supplied from the Stora Enso Group Baltic and Nordic sawmills.

SETA's vision is to maintain and further develop their position as the number one quality supplier of European softwoods in the Australian market.

Sawn Timber

Stora Enso Product Range - Coming to the market

SETA is currently investigating bringing the following product to the local market:

CLT - Cross laminated timber

CLT is commonly applied for external and internal walls, ceilings and roofs. It is composed of spruce, larch or pine (on request) kiln dried, planed, glued with formaldehyde-free adhesive, with 3, 5, 7 or



more layers. The building material offers a short assembly time at the building site because of the prefabricated boards and no time is required for curing.

The advantages of CLT include air tightness, fire resistance, thermal insulation and acoustic insulation and sustainability.

Part B and Part C of the Importer Questionnaire

Please find enclosed at Appendices 1 and 2, our response to Part B and Part C (respectively) of the Importer Questionnaire attached to your letter dated 9 September 2011 in relation to the subject antidumping application above.

Samples request by the Australian Customs and Border Protection Service

We note that the samples requested by the Australian Customs and Border Protection Service ("Customs and Border Protection") do not accurately reflect the nature and volume of products exported to Australia by the Stora Enso Group. In particular, the sample:

- Cover only a minimal number of the products imported into Australia by SETA. This is an
 inadequate basis for assessing dumping for the Stora Enso Group products, given the range of
 items and origins covered by the terms of the investigation. The sample therefore does not provide
 a true and fair view of the nature of the structural timber products offered by the Stora Enso Group
 to the Australian market; and
- Provides a distorted representation of the volume of structural timber products imported into Australia by SETA.

Our preliminary assessment of the sample shipments selected by Customs is that there is a significant difference between the product profile in the sample and the product profile for the total importation data for the period, for structural timber.

We request that Customs and Border Protection reconsider the set of samples requested for the investigation.

Subject to further data review, we will provide a more accurate sample set which captures the normal distribution of imported products and provides a better indication of the volumes of products imported by SETA.

Termination of the Anti-Dumping application

We intend to make a submission to Customs and Border Protection concerning the publication of the dumping duty notice sought in the Applicant's claim.

Our client is of the view that there is no dumping occurring in the structural timber market in Australia and that any injury suffered by Building Supplies Group Holding Pty Ltd ("BSG"), Hyne & Sons Pty Ltd ("Hyne") and Gunns Limited ("Gunns") (collectively, "the Applicants") is not linked to these exports.

Further information will be provided in our submission to Customs and Border Protection. Once these facts are verified, the anti-dumping investigation should be terminated.
