Implementation Plan for Tariff (Year 2010)

- 1. Adjustment of import tax
- (1) In accordance with tariff diminution obligation upon the entrance of WTO, the import tax adjustment is as follows:
- (a) Reduce the MFN tariff rate of 5 tax items including polyester cloth in "import tariff"; fix the MFN tariff rate of 1 tax item, namely wet blue leather, to 6% (see attached form 1); the others remain the same.
- (b) The customs continue inspecting and administrating 9 ex information technology products, the tariff items and rates of which remain the same;
- (c) 45 tariff items in 8 categories including wheat shall be subject to tariff rate quota control, and the tariff items and rates remain the same. Certain amount of cotton import out of quota shall be subject to 5%-40% slide tax. The Urea, combined fertilizer, diammonium phosphate shall be subject to interim quota rate of 1% (see attached form 2).
- (d) Specific duty and compound duties shall be imposed to 55 commodities including frozen chicken, and the tariff rates remain the same(see attached form 3).
- (2) Greenland goes flatfish and part of import commodities shall be subject to temporary tax rate (Please refer to attached form 4).
- (3) Conventional tariff to relevant countries or regions shall be in accordance with trade or favorable tariff agreement between China and relevant countries.
- (a) 1767 tax items commodities originated from Korea, India, Sri Lanka, Bangladesh and Laos shall be subject to conventional tariff in "Asia Pacific treaty".
- (b) Certain commodities originated from Brunei, Indonesia, Malaysia, Singapore, Thailand,

Philippines, Vietnam, Laos, Myanmar, Cambodia shall be subject to conventional tariff in China-ASEAN free trade zone agreement.

- (c) 7029 tax items commodities from Chile shall be subject to conventional tariff in China-Chile Free Trade Agreement.
- (d) 6240 tax items commodities from Pakistan shall be subject to conventional tariff in Sino-Pakistani Free Trade Agreement.
- (e) 7040 tax items commodities from New Zealand shall be subject to conventional tariff in China-New Zealand Free Trade Agreement.
- (f) 2753 tax items commodities from Singapore shall be subject to conventional tariff in China-Singapore Free Trade Agreement.
- (g) 1587 tax items commodities from Hong Kong with standards approved by the country of origin shall be subject to 0 tariff.
- (h) 1209 tax items commodities from Macao with standards approved by the country of origin shall be subject to 0 tariff.
- (4) Special preferential tariff rates shall be imposed on certain tax items commodities in accordance with trade or favorable tariff agreement or decisions of State Council between China and 41 most un-developed countries recognized by UN, including 4 countries from Southeast Asia including Laos, 31 countries from Africa including Ethiopia, 6 countries including Afghanistan.
- (5) General rates shall remain the same.
- 2. Adjustment of import tax
- (1) Export tariff rate in "export tariff" shall remain the same;
- (2) Temporary tariff rates shall be imposed on certain export commodities including eel fry; certain chemical fertilizer and other commodities shall be subject to special export tariffs (see attached form 7). Among those, regarding commodities export tariff imposed on before January 18, 2010, the scope of trade forms covered by tariff remain the same.
- 3. Adjustment of tax tariff and tax items.

Please refer to attached form 8 for adjustment of tariff nomenclature and items. After adjustment, there are 7923 tariff items in tariff 2010 version.
