### **Project details**

Name: KCGM Growth Project

Location: Kalgoorlie, WA

Type: Mine or quarry

Purpose: Upgrade existing facility

Capital expenditure: \$500 million or more

Description: The Kalgoorlie Consolidated Gold Mines (KCGM) operations currently include the Fimiston and Gidji Processing Plants in Kalgoorlie, Western Australia, approximately 600 kilometres east of Perth. The KCGM Fimiston Processing Plant has been expanded on several occasions. The current combined processing rate of the Fimiston and Gidji Processing Plants has typically been 13Mt/a, with rates of up to 15Mt/a recently achieved on softer stockpiled ore. The proposed KCGM Growth Project, once approved, is intended to expand the existing Processing Plant capacity to 23.5Mt/a and, subject to the Final Investment Decision expected in the coming months, will commence during the third quarter of FY2023 and run through until January 2026. The Project's proposed delivery model is structured to have three key packages dealing with enabling works, a major Greenfields (new ore processing facility) EPC Contract and a Brownfields package dealing with all the key tie-ins to the existing Plant. Procurement of goods and services for the Project (including processing plant infrastructure, major equipment packages, office and accommodation buildings, telecommunications tower, civil and concrete works, SMP and El&C works, demolition, commissioning, engineering design, construction services and power supply and installation) will be conducted during the third quarter of 2023 and for the duration of the Project.
