Description: The Balranald critical minerals development is focused on the rutile and zircon rich West Balranald deposit, which also contains material quantities of rare earth minerals. Iluka was granted development consent from the NSW Government to undertake mining at the site of the Balranald Mineral Sands Project (the Balranald Project). The consent allows for the open—cut mining of two mineral sand deposits known as the West Balranald and Nepean deposits located north—west of the town of Balranald. While open-cut mining has been approved in the consent conditions, Iluka will be advancing this project through the use of a novel Borehole Mining technology also approved in the consent conditions. The development plan for Balranald is to deploy two mining units from commencement of operations. Iluka's decision in this regard is based in part on the company's growing confidence in the reliability, ramp up profile and capability of the company's Under Ground Mining (UGM) technology.
