Purpose: Upgrade existing facility

Capital expenditure: \$500 million or more

Description: The Project includes the design, procurement, installation, and commissioning of the new bucketwheel reclaimers including associated structural, mechanical, electrical and communications services. The Project also includes the design and construction of associated off-board scope including bulk earthworks, civil infrastructure, structural works and electrical upgrades to support the functionally safe operation of the new reclaimers. The Proponent has engaged Bechtel (Western Australia) Pty Ltd as the Project's Engineering, Procurement and Construction Management (EPCM) contractor. All Contracts will be under Hamersley Iron Pty. Limited (ACN 004 558 276). The Proponent's primary forum for seeking Australian industry participation will be via the Rio Tinto Buy Local platform. It is anticipated that Australian suppliers will have the capability to participate in the majority of the packages that will be tendered for the Project.
