Description: The Han-Ho H2 Hub project is a significant initiative that focuses on establishing a large-scale green ammonia supply chain between Australia and South Korea. The project intends to leverage renewable energy generation in North Queensland to power a multi-gigawatt hydrogen production facility. The green hydrogen will be used as feedstock for green ammonia production. The project is being delivered by a consortium that includes three Korean conglomerates: SK Gas, Hanwha Impact, and Korea Zinc, with Ark Energy leading the development efforts in Australia. The Project plans to award a head contractor for each major package. Key dates: Feasibility end Q2 CY24, Approvals Submission Q3 CY24 - Q2 CY25, FEED Q3 CY25 - Q4 CY26. FID Q4 CY26.
