1. General Project Details

Description of the project: The Department of Immigration and Border Protection's (DIBP) Yongah Hill Immigration Facility Redevelopment Project includes Decommissioning of existing bedroom and ancillary amenities accommodation in Eagle and Swan compounds and construction of 120 hardened beds in four compounds. The works include the following amenities and facilities:
