 DXC will promote the involvement of Australian Industry and communicate specific opportunities throughout the life of the contract through a variety of organisations, industry briefings, and industry events including: the Australian Information Industry Association (AIIA), the ICT Industry Advocate, CollabIT, SAP Australia User Group (SAPAUG), DXC Technology@Work events, the Partnership Advisory Board Council, Australian universities (e.g. Australian National University), and the Industry Capability Network.(ICN).

4. Opportunities through all tiers of supply and in all stages of the project

- DXC complies with Australian Standards ISO 9000 and 9001 that Australian suppliers can meet and requests from their suppliers to comply accordingly.
- DXC operates a tiered approach to the selection and management of third party suppliers:
 - Agility Alliance Partners form the top tier of our supplier base. Alliance Partners work with DXC to align strategies and create advantage through a joint "go to market" approach, as well as establishing beneficial commercial terms;
 - Approved Suppliers form the second tier, covering all categories of third party spend; and
 Additionally, DXC works closely with niche specialist suppliers who have been selected to
 - meet client specific demands.
- DXC will provide potential suppliers with adequate timeframes to respond to supply opportunities and will assess suppliers equally on the same set of criteria.
- All supplier tiers are core to DXC's ability of successful delivery to its customers. DXC would
 maintain this procedure with specific reference to AIP requirements, flowing down AIP
 requirements to contractors and subcontractors. This will be achieved through a process of
 education and negotiation with contractors and subcontractors. Where requirements flow down,
 contractors and subcontractors will be required to adhere to the principles of the AIP, specifically
 the concept of providing full, fair and reasonable opportunity to Australian industry.
- DXC will promote to Australian industry through its participation in AIIA, its website, and procurement activities, opportunities for Australian industry to partner with DXC to deliver the solution for the WPIT Programme.
- For each Work Package of sufficient size released by the DHS for the WPIT Programme, DXC will provide an opportunity for existing and new Suppliers to quote for new services.

5. Opportunities for longer-term participation

- DXC engages suppliers through its Global Supply Chain group who manage approved Australian Suppliers. The DXC team responding to WPIT Panel requests will work with the DXC Supply Chain Group to source capability from Australian approved suppliers. DXC's strategy is to work with capable and innovative suppliers; providing support where appropriate. For example, DXC is currently working with Stone and Chalk to identify Australian start-ups who bring new ideas and products that DXC can take to our customers. Initiatives such as these are a win/win for the Australian Start-ups, DXC and our customers.
- As a rapidly emerging market, the SAP Social Services Framework and its component modules SAP CRM, PSCD and BRF+, represent rare skill sets on a Global basis. Depending on the work released and won, DXC will be undertaking a training program, for both DXC and Supplier resources, to add SAP Social Services Framework skills to existing SAP skills. This training will provide Suppliers with opportunities to partner with DXC on other SAP Social Services Framework opportunities on a Global basis.
- DXC will work with SME partners to help train and educate them in new technology associated with this engagement.

6. Procedures and Resources

- DXC's WPIT Account General Manager(AGM) is responsible for implementation of the AIP Plan within the WPIT Programme, including:
 - Ensuring the actions outlined in the Communications Strategy to engage with industry both directly and through forums such as SAPAUG) CollabIT, AIIA and ICT Industry Advocate are implemented.

- Engaging DXC Global Procurement teams to ensure awareness and appropriate responses have been developed in relation to opportunities for Australian Industry participation within the WPIT Programme.
