An Itron Australasia Model EM420i polyphase class 1 direct connect static watt hour meter used to measure electrical energy. This meter has the same characteristics as described for the pattern in clause **1.1 Field of Operation** except as follows:

•	Number of phases	3
•	Number of wires	4
•	Rated voltage	3×240/415 V AC

TEST PROCEDURE

Instruments tested for initial verification shall comply with the certificate of approval and technical schedule, and the maximum permissible errors for verifications at the operating conditions in effect at the time of verification.
