DESCRIPTION OF PATTERN

The pattern is of a self-indicating platform weighing machine of 135 lb capacity, 110 lb by 4 oz graduations on the dial and 25 lb by 4 oz graduations on the tare bar.

The pattern is a modification of an instrument previously approved in the State of Victoria under Notice of Approval No 311, which has been modified by replacing the counting headwork with a self-indicating dial headwork incorporating a CLA spring-resistant mechanism as approved in Victorian Notice of Approval No 201.

DESCRIPTION OF VARIANT

1. Having other capacities up to a maximum of 320 lb or 150 kg.
