Statutory Conditions

- (d) That the authority comply with any determinations applying to the authority under regulation 39 of the *National Measurement Regulations 1999* (Cth).

Additional Conditions

In addition to the statutory conditions of appointment of authorities contained in regulation 77 of the *National Measurement Regulations 1999* (Cth) this appointment is also subject to the following conditions:

- (i) Continuing accreditation against AS ISO/IEC 17025 General requirements for the competence of testing and calibration laboratories in the form of NATA accreditation No. 13694.
- (ii) The authority shall not engage a responsible agent or arrange for any measuring instrument to be certified by an agent or anyone under its supervision without obtaining the prior consent of the Chief Metrologist in writing;
- (iii) Discharge of all financial obligations to the National Measurement Institute in respect of this appointment;
